

## Wags to Riches – Care Contract

This is an agreement between WAGS TO RICHES and the pet owner(s) whose signature appears below.

1. By signing this agreement and leaving pet(s) with WAGS TO RICHES, pet owner(s) certifies to the accuracy of all information given about said pet. WAGS TO RICHES reserves the right to deny admittance to pet owner(s)'s pet(s) for any reason at any time.
  
2. Pet owner(s) agrees to pay the current rate for pet care provided in effect on the date pet is checked into WAGS TO RICHES unless other rate(s) was agreed upon. Sitting: Dogs \$40.00/day, Cats \$20.00/day. Daycare: Dogs \$20.00/day, Cats \$15.00/day. Rates may be adjusted for referral and other discounts, behavior, special needs and/or foods, medications and other circumstances as explained in this contract.
  
3. Pet owner(s) further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet(s) during the period said pet is in the care of WAGS TO RICHES. Pet owner(s) further agrees to provide preventative flea/tick treatment and to be financially responsible for any required treatment for fleas/ticks, if determined necessary by the pet care provider. At no cost, upon arrival, Capaction will be given to a pet that has not been treated within the past thirty (30) days.
  
4. WAGS TO RICHES shall exercise reasonable care for the pet(s) delivered by pet owner(s) to WAGS TO RICHES. If interactive daycare is provided, pet owner(s) recognizes and accepts potential risks involved in such activity. It is expressly agreed by pet owner(s) and WAGS TO RICHES that WAGS TO RICHES' liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted. The pet owner(s) further agrees to be solely responsible for all acts or behavior of said pet(s) while it is in the care of the WAGS TO RICHES, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet(s).

5. An Apple Airtag will be attached to pet's collar, if possible. Every precaution will be used when leashing your pet, attaching a tethered line or releasing pet into fenced area of yard.

6. Pet owner(s) further agrees that the pet(s) shall not leave the facility until all charges due are paid by pet owner(s) at pick up of pet, when billed by WAGS TO RICHES, or with proper payment arrangements agreed upon by both parties. In the case of long-term stays over thirty (30) days, pre-payment and/or payments may be required every 1-2 weeks to cover boarding costs. If pet owner(s) defaults on payment for any reason, pet owner(s) is responsible for any/all legal expenses accrued by WAGS TO RICHES in association with the collection of payment.

7. Any pet left for 14 days past the scheduled pick-up date will be deemed abandoned. WAGS TO RICHES will make all reasonable attempts to contact the pet owner(s). If, after all reasonable attempts have been made, there is no response from the pet owner(s), the pet(s) will become the property of WAGS TO RICHES; as such, WAGS TO RICHES will have the authority to do with that pet(s) as WAGS TO RICHES sees fit. After thirty (30) days of boarding an abandoned pet, WAGS TO RICHES may deliver the pet to foster care or a humane ("no kill") animal shelter. WAGS TO RICHES will make every possible attempt to notify you of this action. Once in the care of a foster or humane animal shelter, it would be the responsibility of the pet owner(s) to ensure proper care and acquisition of the pet. These actions will not relieve the pet owner(s) from paying all charges for services rendered, legal costs and/or costs incurred due to collection for services.

8. The pet owner(s) shall hold harmless WAGS TO RICHES, its staff, owner, volunteers and assignees for any damages. WAGS TO RICHES will make every reasonable effort to ensure the safety, comfort and good health of the pet owner(s)'s animal(s). WAGS TO RICHES cannot predict or prevent all contagious viruses, diseases or infectious conditions (including bacterial, fungal or parasitic) for which there is no vaccine or vaccine efficacy. Any treatment for such is the responsibility of pet owner(s).

9. WAGS TO RICHES is not responsible for any accidents due to Acts of God - for example, fire, tornado or other storm. WAGS TO RICHES is not responsible for any theft exceeding a combined value of \$100.00. WAGS TO RICHES is not responsible for any damage to bedding, toys, etc. brought in by pet owner(s) for pet(s) during it's time of sitting.

10. Pet owner(s) specifically represents that he or she is the sole owner of the pet(s), free and clear of all liens and encumbrances.

11. Pet owner(s) specifically represents to WAGS TO RICHES that, to pet owner(s)'s knowledge, the pet(s) has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this agreement, pet owner(s) also agrees to notify WAGS TO RICHES of any known exposure of pet(s) to a communicable disease and hold pet out of attending WAGS TO RICHES until pet(s) is symptom-free for a minimum of 7 days or with

written veterinary clearance. Pet owner(s) further agrees to maintain currency of vaccinations as required by the State of Missouri and WAGS TO RICHES policy. Proof is required by start time of sitting, daycare or grooming session.

12. If pet(s) becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, WAGS TO RICHES, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet(s); the expenses thereof shall be paid by the pet owner(s). Should a pet require care, WAGS TO RICHES will make every attempt to reach pet owner(s) or their representatives. If unable to reach pet owner(s), WAGS TO RICHES and/or the attending veterinarian will proceed with treatment based on the best interest of the pet. Refer to #3 regarding costs incurred.

13. This agreement contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, personal representatives and assigns of the pet owner(s), and WAGS TO RICHES for all pets and pet stays.
